**ORDER SPECIFYING MEANS OF PROVIDING NOTICE OF  
COURT’S DECISION AND ORDERS REGARDING ADDITIONAL  
MOTIONS FOR RELIEF FROM THE 2009 BAR DATE**

On this same day the Court has issued its Decision regarding 260 additional motions seeking relief from the August 12, 2009 bar date in these cases so that they may pursue claims against the Tronox Incorporated Tort Claims Trust (the “**Trust**”). In order to provide proper notice to the movants, and to ensure adequate notice of the deadlines for the filing of any appeals, the Court hereby orders as follows:

1. Two separate orders will be entered that reflect the Court’s rulings, and separate forms of notice will be provided to the movants who are covered by different Orders. More particularly:

(a) An Order in the form of **Exhibit A** will be entered **on September 12, 2024** with respect to motions that have been denied in their entirety. **Exhibit A-1** will be attached to such Order and will set forth the Court’s rulings as to the individual motions that are covered by that Order; and

(b) An Order in the form of **Exhibit C** will be entered **on September 12, 2024** with respect to motions that have been denied insofar as they relate to diseases and conditions that were diagnosed before the August 12, 2009 bar date and that have been referred to the Trust for resolution insofar as they relate to diseases or conditions that were

first diagnosed after the August 12, 2009 bar date. **Exhibit C-1** will be attached to such Order and will set forth the Court's rulings as to the individual motions that are covered by that Order.

2. The Trust is hereby directed to send notices in the form attached as **Exhibit B** to the Movants whose motions are covered by the Order that is to be entered as Exhibit A and to do so on or before **August 26, 2024**. Each Movant who receives that notice should also receive a copy of the Order that will be entered as Exhibit A as well as a copy of the page from Exhibit A-1 that relates to that Movant's motion.

3. The Trust is directed to send notices in the form attached as **Exhibit D** to the Movants whose motions are covered by the Order that is to be entered as Exhibit C and to do so on or before **August 26, 2024**. Each Movant who receives that notice should also receive a copy of the Order that will be entered as Exhibit C as well as a copy of the page from Exhibit C-1 that relates to that Movant's motion.

4. The Trust shall post copies of the Court's Decision and of this Order (and its attachments) on the Trust's web-site.
